Relative strength is a momentum technique that relies on unbiased, unemotional and objective data, rather than biased forecasting and subjective research. Relative strength is a way of recording historic performance patterns, and the portfolio consultant uses relative strength signals as a trend indicator for current momentum and future performance trends of a security versus another one.

- Equally Weight 50 Strongest Companies Based on Rankings System







Risk Considerations
