Dynamic Sector Income Trust 70% Equities, 30% CEFs and/or ETFs

- High dividend yield
- · Sector focused taking into account current market conditions and our future market outlook

Interest Rate Outlook Trust 40% Equities, 60% CEFs and/or ETFs
